OUR GOALS

The Selkirk Ave Farmers' Market is managed by the North End Community Renewal Corporation (NECRC) at 509 Selkirk Ave. The goal of the market aims to improve the health of the community through making our local food systems more sustainable, accessible, and equitable. The market provides an opportunity to local producers, groups, and businesses to buy and sell produce and/or other products. The market provides the community access to fresh, locally grown produce, an important aspect of healthy eating. We encourage all crafters and creators from the community to participate and showcase their talents.

TERMS & CONDITIONS

1. The Selkirk Avenue Farmers' Market will run from **June 27th** through **August 29th** from **12-4pm** at the Bell Tower on Selkirk and Powers (also known as the Powers Park Plaza)
2. Selling on the market site is permitted only on market days.
3. Sellers must abide by the City of Winnipeg/Province of Manitoba regulations, specifically the Guidelines for the Operations of a Temporary Food Ticket.

4. The market will not happen where it is storming at 12pm. Vendors will be notified by phone.
5. We encourage vendors to bring their own tables and chairs for their convenience. Vendors are also welcome to request a table, chair, and tent (tents are a first come first serve basis)
6. The City of Winnipeg and/or NECRC are not responsible for lost, stolen, or damaged items.
7. Market equipment cannot be left on site outside of market hours.
8. Free parking is available on residential streets.
9. NECRC will promote the Selkirk Avenue Farmers' Market. Vendors may bring additional promotional materials to be posted at their table only. Vendors are encouraged to contact northendfarmersmarket@gmail.com in advance with any produce or products that you would like to promote. We will make every effort to include all requests.
10. Although long-term commitment is not required, we request at least 2 days' notice if you are not going to attend the market.
